John spent more than fifteen years at the Department of Justice, including over a decade at PIN where he served for five years as Principal Deputy and Acting Chief of the Section. He led hundreds of investigations and prosecutions involving criminal abuses of the public trust by federal, state, and local public officials, companies, and corporate officers. These matters involved procurement, healthcare, mortgage, securities, and honest services fraud, bribery, money laundering, election crimes, national security, and tax offenses. John also previously worked as an Assistant United States Attorney and an Assistant Federal Public Defender and practiced in the litigation department of a leading global law firm. John has tried sixteen federal cases, both as a prosecutor and defense counsel, handled twenty appeals, and supervised dozens of additional trials and appeals nationwide. John also regularly interfaced with House and Senate committees regarding parallel congressional investigations and proposed legislation; handled congressional inquiries directed to the Department of Justice; and prepared Department officials for congressional testimony, including the Attorney General, Deputy Attorney General, and Assistant Attorney General for the Criminal Division.

In addition to his active practice, John teaches a constitutional law course at Georgetown University Law Center and was an instructor at DOJ's National Advocacy Center on Developments in Fraud, Public Corruption, and Election Law; Jury Instructions; and Investigative Techniques. He is a frequent speaker on issues of national security and election law, and has appeared on NPR, CNN, NBC, and the Lawfare Institute.
